

# DACA is Ending: Know Your Rights

September 2017



## Know What This Means

1. The U.S. Department of Homeland Security (DHS) will no longer accept new applications for Deferred Action for Childhood Arrivals (DACA)
2. People currently enrolled in DACA will be able to continue working until their permits expire
3. People whose DACA permits expire between September 5, 2017 and March 5, 2018, may file for a two-year renewal by October 5, 2017
4. DHS will continue to adjudicate DACA applications that were filed prior to September 5, 2017

## Conozca lo que esto significa:

1. El Departamento de Seguridad Nacional de los Estados Unidos (DHS) ya no aceptará nuevas aplicaciones para DACA
2. Personas con DACA podrán continuar trabajando hasta que sus permisos se expiren
3. Las personas con DACA que se expire entre el 5 de septiembre de 2017 y 5 de marzo de 2018, tienen hasta el 5 de octubre de 2017 para mandar una solicitud de renovar los beneficios de DACA por otros dos años
4. DHS continuara procesando solicitudes de DACA que fueron aceptadas antes al 5 de septiembre de 2017
