Fingerprint Appointments (for asylum in court only)

- Prints are good for 15 months
- Must be current on the date of the merits hearing
- Attorney is responsible for requesting appointment
- Contact NIJC if you have not obtained a fingerprint appointment by two months prior to the merits hearing
- See NIJC's asylum manual and appendix for instructions

Employment Authorization Document (EAD)

- Eligible 150 days after filing form I-589
- USCIS can grant an EAD 180 days after filing I-589
- Declining an expedited hearing, requesting a continuance, or changing venue may stop the clock.
- See NIJC's asylum manual for more information.

Case Preparation Checklist

- I-589 application with passport photo
- Legal memo (asylum office) or brief (court)
- G-28 (asylum office) or E-28 (court) appearance form
- Annotated index of documents
- Supporting documents, including
 - Client affidavit
 - Witness/expert affidavits
 - Client identity documents
 - Country condition reports
 - Corroborating evidence

Filing Reminders

- All documents must be translated into English and have a signed certificate of translation.
- Unless the judge ordered otherwise, all documents must be filed with the court 15 calendar days before the merits hearing.
- See the Immigration Court Practice Manual for required filing format
