The U Visa

The U Visa was created to keep communities safe by strengthening the ability of law enforcement agencies to investigate and prosecute cases of domestic violence, sexual assault, trafficking and other crimes while offering humanitarian protection to victims of such crimes. The U Visa provides a mechanism for victims of certain qualifying crimes to remain in the United States to assist in an investigation/prosecution of those who have perpetrated crimes against them.

Benefits of the U Visa include employment authorization for up to four years. An individual with an approved U Visa may be eligible to apply for legal permanent residency and even naturalization in the future. Additionally, certain qualifying family members of the principal U Visa applicant may be eligible to apply for a U Visa as derivatives.

An immigrant may be eligible for a U Visa if they:

- Have suffered substantial mental or physical harm as a victim of a qualifying crime,
- Possesses information concerning the criminal activity,
- Have been helpful, are being helpful, or are likely to be helpful to law enforcement during the investigation and/or prosecution of the crime; and
- Demonstrate that the qualifying crime violates U.S. federal or state law.

U Visa applicants must be admissible to the United States as a nonimmigrant or obtain a waiver of inadmissibility.

Pro Bono Representation in U Visa Application Involves:

- Direct client engagement including interviewing clients and document collection
- Preparing client affidavit in support of U Visa and waiver of inadmissibility if necessary
- Preparing and filing applications
- Advising the client on future eligibility for legal permanent residency, employment authorization for any derivatives In the United States, and consular processing for any derivatives outside the United States



Our Pro Bono Partnership:

- NIJC pro bono attorneys are expected to:
 - 0 Participate in a training
 - Provide interpretation and/or translation services, as needed
 - Produce a comprehensive application that involves preparing a detailed client affidavit, supporting documentation, and a legal memorandum.
- NIJC provides:
 - Trainings conducted by experts
 - Policy and practice updates regarding any changes within the immigration system that may impact clients
 - Detailed practice manuals, practice advisories, and samples produced
 - Technical support through the life of the case
 - Resources for trauma-informed representation
- Expected number of hours:



 Due to on-going challenges to immigration law and policy, the length of a case can vary. Pro bono attorneys can expect to dedicate 20 – 40 hours to file the case. Adjudication takes several years. Pro bono attorneys are expected to maintain the case, remain in contact with the client through the final decision, and inform NIJC of any circumstance that affects their ability to stay on the case as soon as it arises.


