## CHICAGO LEGAL PROTECTION FUND

2024 ANNUAL REPORT

The Chicago Legal Protection Fund (LPF) is a citywide initiative supporting organizations that protect and empower immigrants in Chicago. The fund launched in January 2017 to advocate for the more than 180,000 immigrants and their families in Chicago following the 2016 presidential election.

In its eighth year, LPF continues to protect and strengthen the Chicago immigrant community through its collaborative model that links 11 community navigator organizations led by The Resurrection Project (TRP) with legal counsel and expertise from the National Immigrant Justice Center (NIJC).

Community Navigators and legal advocates have prevented hundreds of deportations, kept families together, connected the immigrant community to vital resources, facilitated personal and community growth through leadership development, and paved the way for many undocumented immigrants to adjust their status.

### **COMMUNITY NAVIGATORS**





From January to August of 2024, LPF funded the recruitment and training of **266** Community Navigators. Navigators receive regular training and development opportunities and often grow into leaders through their work.

This year, Community Navigators reached **42,879** individuals through immigrant education presentations and accompaniments.

"My family immigrated from Mexico. One of the things that we do as navigators is educate people on their rights as immigrants. I was able to learn about what a properly issued warrant looks like, the right to remain silent, things I never learned at school and my parents never talked to me about. As a navigator I educated others in my community, but was also able to take it back home to inform my family and help prepare us for any type of situation that could come up."






### NATIONAL IMMIGRANT JUSTICE CENTER LEGAL SERVICES

For 40 years, the National Immigrant Justice Center (NIJC) has provided expert immigration legal services to vulnerable immigrants. Since 2017 through the Legal Protection Fund, NIJC's dedicated staff of attorneys and experienced legal professionals have provided expert immigration legal representation to Chicago residents in over 5,000 cases, boasting a 97% success rate, and provided more than 10,000 legal screenings.

### NIJC'S TEAM OF EXPERIENCED IMMIGRATION LAW ATTORNEYS AND ADVOCATES:





Offer immigration legal representation to people who face unique barriers in the legal system, including representing Chicagoans before immigration court, the Department of Homeland Security (DHS), and the State Department

### NIJC'S LEGAL EXPERTISE HELPS INTERNATIONAL STUDENT OBTAIN PERMANENT RESIDENCE

Daniel\* came to Chicago from Ethiopia on a student visa with hopes of finding his father. After the father and son reunited, Immigration and Customs Enforcement (ICE) initiated Daniel's deportation proceedings for overstaying his visa. NIJC represented Daniel and successfully terminated the government's efforts to deport him. When DHS appealed, NIJC represented Daniel to ensure that he could stay in Chicago with his father. His father had asked a non-attorney to help him secure a visa for Daniel to live with him in the U.S. Because he did not have access to legal advice, he failed to establish his parental relationship with his son in his application. NIJC took over Daniel's case to correct the error and represent him in becoming a permanent resident. Daniel is now secure in the knowledge that he and his father will remain together.


