The facility will usually send a return fax to confirm your call. When you call the facility for the call, press 0 for the operator. To forward legal documents to clients or request return signatures on legal documents please scan documents with a cover sheet and **e-mail** them to DCDFSuper@co.dodge.wi.us with request also stated in the body of the e-mail. Calls are not available between 11:30 - 12:30, 1:50 - 2:30, or 4:30 - 5:30.

To set up conference call, fax KCDC or Kenosha Jail, depending on where your client is (it will usually be KCDC), at least 24 hours in advance, and include client name, the date and time that want the conference call. **Each request should be sent on a separate fax sheet.**

Can schedule calls on any day-Sunday through Saturday-between 8:30am-10:30am; 1:00pm-1:30pm; 2:30pm-3:30pm; and 6:00pm to 8:00pm. Be sure to include a phone number at which you can be reached as the facility usually calls to confirm that the call has been scheduled.
